The Local 282 Job Training Trust Fund is pleased to announce a partnership with CPR123 to provide lifesaving training and instruction on the use of an Automated External Defibrillator (AED). The course will include:

- Relieving victim of choking (conscious and unconscious)
- Use of an Automated External Defibrillator (AED)
- CPR instruction including high-quality compressions, airway management, breathing, and how to use a mask.
- Each participant will receive an **American Heart Association** certification card upon completion of the course. These cards confirm your certification for 2 years.

Class size and frequency will be based on interest from you and your covered dependents. Enclosed is a flyer summarizing what to expect from the training. The course is free for the participant and only \$80 for your covered dependent.
