Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$6,663,445 as of February 28, 2015, compared to \$6,207,705 as of March 1, 2014. During the plan year the plan experienced a change in its net assets of \$455,740. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$10,512,574 which included employer contributions of \$10,418,482, employee contributions of \$0, gain/loss of \$0 from the sale of assets, and earnings from investments of \$94,092

Total plan expenses were \$10,056,834. These expenses included \$399,600 in administrative expenses and \$9,657,234 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
