The total premiums paid for the plan year ending February 28, 2014 were \$5,280,278.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$119,834,764 as of February 28, 2014, compared to \$115,671,153 as of March 1, 2013. During the plan year the plan experienced a change in its net assets of \$4,163,611. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$64,913,887 which included employer contributions of \$47,319,742, employee contributions of \$275,719, gain/loss of \$180,226 from the sale of assets, and earnings from investments of \$11,596,575

Total plan expenses were \$60,750,276. These expenses included \$10,229,829 in administrative expenses and \$50,520,447 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
